Performers Insurance are offering you the chance to design your own Festival Insurance package from just **£75.00** including tax and fees.

## Standard Cover

Our standard cover is compulsory and will cover your Legal Liability whilst at your chosen Festival for the duration of the Festival (maximum period 31 days)

## Standard cover limits

Public Liability £5,000,000  
Employers Liability £10,000,000.

## Premiums

1 to 8 shows = £75.00  
1 to 15 shows = £100.00  
1 to 30 shows = £150.00  
30+ shows = Refer

## Optional Cover Extensions

Loss or Damage to Theatrical Equipment Cover - £1,000 sum insured	= £25.00
Loss or Damage to Theatrical Equipment Cover - £2,000 sum insured	= £35.00
Loss or Damage to Theatrical Equipment Cover - £3,000 sum insured	= £50.00
Loss or Damage to Theatrical Equipment Cover - £5,000 sum insured	= £65.00
Cancellation Expenses - £ 2,500 (see definition below)	= £25.00
Cancellation Expenses - £ 5,000 (see definition below)	= £50.00
Cancellation Expenses - £10,000 (see definition below)	=£80.00

## Preview Cover Extension

If you are previewing your show anywhere in the UK prior to the Festival, we are able to offer our Standard Cover above at a cost of £25.00 per preview.

## Terms & Conditions:

A full policy wording is available online to view, download or on request but please note the following:

- You will be responsible for the first £100 of each and every claim for loss or damage to theatrical equipment
- Losses from Unattended Vehicles are excluded
- Theft is covered but subject to their being visible signs of forced entry to the premises.
- Cancellation Expenses cover only operates following damage to the venue and subsequent cancellation by the venue.
- Cover operates for events organised at the chosen Festival only.
- Terrorism Cover is excluded.
- Changes to the policy once purchased are subject to a £25.00 administration charge in addition to any additional premiums that may be due.

All premiums quoted include Insurance Premium Tax (IPT) at the appropriate rate and £10.00 policy issue fee.

## **\*\*\*NON UK COMPANIES\*\*\***

For non UK companies and individuals the standard premiums apply but Public Liability only will apply.
